- 1.2 The Special Regulations of Yachting Australia Part 1 Category 6 apply to trailables and Part 2 to off the beach dinghies
- 1.3 The rules of the classes competing. Boats failing to comply with their Class Rules will have their yardstick adjusted by the race committee.

**2 Entries:**

- 2.1 Entries are invited from all classes of trailable yachts and off the beach Catamarans, Dinghies. They will be divided into the following divisions.

Division 1 Monohull, Trailable	Division 2 Catamarans
Division 3 Juniors
